## **DOG BOARDING & DAYCARE AGREEMENT**

Thank you for choosing Lynneville Labradors for your pet boarding and daycare needs.

**Requirements**: All canines must be up to date on all vaccines, including Bordetella, Rabies, and DHPP. Official updated vaccination records must be provided prior to entry into daycare or boarding and must be administered at least 3 days prior to either service. We reserve the right to refuse to accept a pet at check in for any reason including, without limitation, if it appears to us that the pet is sick, injured, in pain or that its behavior could jeopardize the health or safety of other pets or our staff.

If your pet has a medical condition or is on any medication, your pet must be evaluated prior to boarding or Day Care and we require a Medical Release to be completed.

1.) You have the option to name an adult (over the age of 18) as your agent or emergency contact. This person should not be traveling with you if you are leaving town. If we cannot reach you, you authorize us to contact your agent. You agree that your agent shall have your full and complete authority to make any and all decisions, including those related to the health of your pet and the expenditure of funds, for or on behalf of you and your pet.

**Emergencies:** If your pet(s) becomes ill or injured in what is deemed by our employees as nonemergency, and we are unable to reach you, please indicate your wishes below:

Please perform whatever services the doctor deems necessary for the best care of my pet until someon can be reached.
I authorize up to \$ to be spent on such medical services.
Do not administer any medical services until specific authorization is given.

## In cases we believe to be serious, we will take your pet to the emergency vet first before trying to contact you!

- 3.) <u>Liability:</u> You acknowledge and agree that in an unlikely event your pet is injured by another pet you release LYNNEVILLE Labradors and its employees from any liability for such injury. If your pet injures another pet, you will be solely responsible for any injury to the other pet (s) as well as your own pet and you release LYNNEVILLE Labradors and its employees from any liability for such injury. You understand that it is possible for a pet to become ill even if vaccinated. You assume all the risks and accept the responsibility of all costs for treatments. You further agree to hold the owners and employees of LYNNEVILLE Labradors harmless from expenses incurred for such treatment. If your pet destroys any property of LYNNEVILLE Labradors during his/her stay with us, you acknowledge and agree that you are responsible for charges incurred to replace such items.
- 4.) <u>Payment for Services</u>: You agree to pay us for the services we provide to your pet during each visit at the rates set forth at the start of such visit. Charges begin on the day you leave your pet. If you do not pay your bill in full at, check out, LYNNEVILLE LABRADORS may retain custody of your pet, at additional expense until the bill is paid in full. For any stay's longer then 72 hours a 50% deposit is due at check-in time.

- 5.) **Dog Daycare**: Please be advised your pet will co-mingle with other dogs (if "dog-friendly"). Infectious diseases, minor injuries, dog bites, etc. may occur even when properly vaccinated dogs interact with each other. Your pet may also be boarded at various times throughout the day for breaks or during check in/check-out times.
- 6.) **Personal Items**: Do not bring items with your pet that are valuable or irreplaceable. LYNNEVILLE LABRADORS is not responsible for loss or damage to personal items or toys left with your pet.
  - All medications must be in a container with a current prescription label from your veterinarian. In the event my pets must board with prescription and topical medications, I must complete and sign the Lynneville Labradors Medication addendum.
  - Supplements not labeled for animals or prescribed by a veterinarian will only be given with your
    permission and you assume responsibility for their use. Supplements and over-the-counter tablets
    may be premixed with food for no extra charge, however, Lynneville cannot be held responsible for
    my pet ingesting the product.
- 7.) Pets not picked up on departure date/ Abandoned: If you or your agent does not pick up your pet at the agreed time you hereby authorize us to continue to provide the services as set forth in this Agreement at your expense. If the pet is deemed abandoned under local, state, or federal laws LYNNEVILLE LABRADORS will attempt to contact you by telephone and or in writing advising you that if your pet is not picked up within a reasonable time period your pet will be delivered to a third party adoption partner, animal control, The Burlington County Humane Society or other similar government agency. You understand that you may lose ownership of your pet under the circumstances. If you fail to pick up your pet for any reason you release LYNNEVILLE LABRADORS from all further liability and responsibility for your pet. You shall remain liable to us for all unpaid charges. Including the court costs and reasonable attorney's fees incurred in the collection of the charges.
- 8.) **Miscellaneous Provision**: This written agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for in this agreement. We reserve the right to use photographs or video footage of your pet taken during their stay. These images may be used for marketing materials, either in print form or on the internet. This agreement will remain in effect for any current or future pets you may bring to LYNNEVILLE LABRADORS until the time it may be updated.
- 9.) In the event my dog was to bite someone while boarding and is placed under an Order of Quarantine by the Bureau of Dog Law Enforcement, it may be necessary for my dog to remain at a Lynneville facility for the 10-day observation period at my expense.

I hereby contract with the owner that my pets will be in good health free from illness with any communicable condition/s within the last 14 days before boarding each time I bring my pets. I further understand that it is my responsibility to inform Lynneville Labradors and its staff of any previous events in which my pets have climbed fences, destroyed fencing, harmed, or shown aggressive or threatening behavior towards any person or dog.
